### GENERAL INFORMATION

#### I. Purpose

FERC Form No. 1 (FERC Form 1) is an annual regulatory requirement for Major electric utilities, licensees and others (18 C.F.R. § 141.1). FERC Form No. 3-Q (FERC Form 3-Q) is a quarterly regulatory requirement which supplements the annual financial reporting requirement (18 C.F.R. § 141.400). These reports are designed to collect financial and operational information from electric utilities, licensees and others subject to the jurisdiction of the Federal Energy Regulatory Commission. These reports are also considered to be non-confidential public use forms.

#### II. Who Must Submit

Each Major electric utility, licensee, or other, as classified in the Commission's Uniform System of Accounts Prescribed for Public Utilities and Licensees Subject To the Provisions of The Federal Power Act (18 C.F.R. Part 101), must submit FERC Form 1 (18 C.F.R. § 141.1), and FERC Form 3-Q (18 C.F.R. § 141.400).

Note: Major means having, in each of the three previous calendar years, sales or transmission service that exceeds one of the following:

- (1) one million megawatt hours of total annual sales,
- (2) 100 megawatt hours of annual sales for resale,
- (3) 500 megawatt hours of annual power exchanges delivered, or
- (4) 500 megawatt hours of annual wheeling for others (deliveries plus losses).

#### III. What and Where to Submit

(a) Submit FERC Forms 1 and 3-Q electronically through the forms submission software. Retain one copy of each report for your files. Any electronic submission must be created by using the forms submission software provided free by the Commission at its web site: <http://www.ferc.gov/docs-filing/forms/form-1/elec-subm-soft.asp>. The software is used to submit the electronic filing to the Commission via the Internet.

(b) The Corporate Officer Certification must be submitted electronically as part of the FERC Forms 1 and 3-Q filings.

- b) FERC Form 3-Q for each calendar quarter must be filed within 60 days after the reporting quarter (18 C.F.R. § 141.400).

**V. Where to Send Comments on Public Reporting Burden.**

The public reporting burden for the FERC Form 1 collection of information is estimated to average 1,168 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data-needed, and completing and reviewing the collection of information. The public reporting burden for the FERC Form 3-Q collection of information is estimated to average 168 hours per response.

"Point-to-Point Transmission Reservations" are described in Order No. 888 and the Open Access Transmission Tariff. For all transactions identified as LFP, provide in a footnote the

termination date of the contract defined as the earliest date either buyer or seller can unilaterally cancel the contract.

## EXCERPTS FROM THE LAW

### Federal Power Act, 16 U.S.C. § 791a-825r

Sec. 3. The words defined in this section shall have the following meanings for purposes of this Act, to with:

(3) 'Corporation' means any corporation, joint-stock company, partnership, association, business trust, organized group of persons, whether incorporated or not, or a receiver or receivers, trustee or trustees of any of the foregoing. It shall not include 'municipalities, as hereinafter defined;

(4) 'Person' means an individual or a corporation;

(5) 'Licensee, means any person, State, or municipality Licensed under the provisions of section 4 of this Act, and any assignee or successor in interest thereof;

(7) 'municipality means a city, county, irrigation district, drainage district, or other political subdivision or agency of a State competent under the Laws thereof to carry and the business of developing, transmitting, unitizing, or distributing power; .....

(11) "project' means. a complete unit of improvement or development, consisting of a power house, all water conduits, all dams and appurtenant works and structures (including navigation structures) which are a part of said unit, and all storage, diverting, or fore bay reservoirs directly connected therewith, the primary line or lines transmitting power there from to the point of junction with the distribution system or with the interconnected primary transmission system, all miscellaneous structures used and useful in connection with said unit or any part thereof, and all water rights, rights-of-way, ditches, dams, reservoirs, Lands, or interest in Lands the use and occupancy of which are necessary or appropriate in the maintenance and operation of such unit;

"Sec. 4. The Commission is hereby authorized and empowered

(a) To make investigations and to collect and record data concerning the utilization of the water 'resources of any region to be developed, the water-power industry and its relation to other industries and to interstate or foreign commerce, and concerning the location, capacity, development -costs, and relation to markets of power sites; ... to the extent the Commission may deem necessary or useful for the purposes of this Act."

"Sec. 304. (a) Every Licensee and every public utility shall file with the Commission such annual and other periodic or special\* reports as the Commission may be rules and regulations or other prescribe as necessary or appropriate to assist the Commission in the -proper administration of this Act. The Commission may prescribe the manner and FERC Form in which such reports salt be made, and require from such persons specific answers to all questions upon which the Commission may need information. The Commission may require that such reports shall include, among other things, full information as to assets and Liabilities, capitalization, net investment, and reduction thereof, gross receipts, interest due and paid, depreciation, and other reserves, cost of project and other facilities, cost of maintenance and operation of the project and other facilities, cost of renewals and replacement of the project works and other facilities, depreciation, generation, transmission, distribution, delivery, use, and sale of electric energy. The Commission may require any such person to make adequate provision for currently determining such costs and other facts. Such reports shall be made under oath unless the Commission otherwise specifies\*.10

"Sec. 309. The Commission shall have power to perform any and all acts, and to prescribe, issue, make, and rescind such orders, rules and regulations as it may find necessary or appropriate to carry out the provisions of this Act. Among other things, such rules and regulations may define accounting, technical, and trade terms used in this Act; and may prescribe the FERC Form or FERC Forms of all statements, declarations, applications, and reports to be filed with the Commission, the information which they shall contain, and the time within which they shall be filed..."

#### **General Penalties**

The Commission may assess up to \$1 million per day per violation of its rules and regulations. *See* FPA § 316(a) (2005), 16 U.S.C. § 825o(a).

## Westar Generating, Inc.

### Notes to Financial Statements

#### 1. DESCRIPTION OF BUSINESS

Westar Generating, Inc (Westar Generating) is a rate-regulated electric utility incorporated in 1999 in the State of Kansas. Unless the context otherwise indicates, all references in these notes to "the company," "Westar Generating, Inc.," "us," "its" and similar words are to Westar Generating. Westar Generating is a wholly-owned subsidiary of Westar Energy, Inc. (Westar Energy), and Westar Energy is a wholly-owned subsidiary of Evergy, Inc. (Evergy).

Westar Generating owns a 40% undivided interest in the State Line Combined Cycle Generating Facility (State Line) located near Joplin, Missouri, and sells all its portion of the electric power to Westar Energy. The Empire District Electric Company (EDE) owns the remaining 60% and operates the facility.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

For the purpose of this report, the financial statements are prepared in accordance with the accounting requirements of the Federal Energy Regulatory Commission (FERC) as set forth in its Uniform System of Accounts and published Accounting Releases, which is a comprehensive basis of accounting other than generally accepted accounting principles. The principal difference from accounting principles generally accepted in the United States of America relates to the presentation of deferred income taxes.

Events which occurred subsequent to the date of the balance sheet have been evaluated for potential recognition or disclosure in the financial statements through April 18, 2019, the date these financial statements were available to be issued.

##### Use of Management's Estimates

When Westar Generating prepares its financial statements, it is required to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues and expenses, and related disclosure of contingent assets and liabilities at the date of its financial statements, and the reported amounts of revenues and expenses during the reporting period. Westar Generating evaluates its estimates on an ongoing basis, including those related to inventories, depreciation, income taxes, environmental issues, contingencies and litigation. Actual results may differ from those estimates under different assumptions or conditions.

##### Property, Plant and Equipment

Westar Generating records the value of property, plant and equipment at cost. The cost of additions to utility plant and replacement units of property are capitalized. Maintenance costs and replacement of minor items of property are charged to expense as incurred. When units of depreciable property are retired, the original cost and removal cost, less salvage value, are charged to accumulated depreciation. Utility plant is depreciated using the straight-line method. The rates are based on an average annual composite basis using group rates that approximate 4.0% for 2018 and 2017. .

##### Capital Stock

Westar Generating's Articles of Incorporation provide for 1,000 authorized shares of common stock, all of which were issued and outstanding at December 31, 2018. All of Westar Generating's common stock is owned by Westar Energy.

##### Revenue Recognition

Energy sales are recognized when energy is transmitted to Westar Energy.

### Income Taxes

Westar Generating uses the asset and liability method of accounting for income taxes. Under the asset and liability method, deferred tax assets and liabilities are recognized for the future tax consequences attributable to temporary differences between the financial statement carrying amounts and the tax basis of existing assets and liabilities. Westar Generating recognizes the future tax benefits to the extent that realization of such benefits is more likely than not.

### 3. RATE MATTERS AND REGULATION

Westar Generating sells power to Westar Energy at an established rate under terms outlined in an agreement filed in Docket No. ER13-1210 and accepted by the FERC in January 2014.

The Tax Cuts and Jobs Act (TCJA), which was signed into law in December 2017, significantly reformed the Internal Revenue Code, generally effective January 1, 2018. The TCJA contained significant changes to federal corporate income taxation, including, in general and among other things, a federal corporate income tax rate decrease from 35% to 21% effective for tax years beginning after December 31, 2017, limiting the deduction for net operating losses and eliminating net operating loss carrybacks for losses after 2017, and eliminating Westar Generating's use of bonus depreciation on new capital investments.

In December 2017, Westar Generating remeasured its deferred tax liabilities to the new federal corporate income tax rate of 21%. The result of this remeasurement was a reduction in the net deferred tax liability of approximately \$3.6 million representing the amount of excess deferred income taxes (EDIT) that will be used to reduce future customer rates. Westar Generating recorded an increase in regulatory liabilities of approximately \$4.9 million. The additional \$1.3 million of regulatory liabilities was needed to reflect the future net revenue reduction required to return previously collected income taxes to customers and was offset with a \$1.3 million deferred tax asset. There was no amortization of EDIT in 2018 since Westar Generating does not yet have a mechanism in place to share the net tax benefits with its FERC customers. Westar Generating will use the average rate assumption method (ARAM) for amortization of its Protected EDIT. ARAM is an approach provided in the TCJA to refund depreciation-related EDIT over the remaining book lives of the underlying assets which are estimated to be approximately 30 years. The EDIT in account 254 will amortize to account 411.

## 7. RELATED PARTY TRANSACTIONS

Westar Generating is a wholly-owned subsidiary of Westar Energy and, as of June, 4, 2018, Westar Energy is a wholly-owned subsidiary of Evergy, Inc. Costs allocated to Westar Generating by Westar Energy may not reflect what actual costs would be if it were not a wholly-owned subsidiary and, therefore, Westar Generating's financial results may be different.

Westar Generating generates and sells electric power to Westar Energy. The source of this power is Westar Generating's 40% interest in State Line. Sales to Westar Energy for the year ended December 31, 2018 were approximately \$41.1 million compared to approximately \$41.0 million for the same period in 2017.

Westar Generating's cash management function, including cash receipts and disbursements, is performed by Westar Energy. An intercompany account is used to record net receipts and disbursements between the companies. The net amount receivable from Westar Energy as of December 31, 2018, and December 31, 2017, was approximately \$92.7 million and \$85.8 million, respectively.

Westar Generating did not declare and record dividends to Westar Energy in 2018. Westar Generating declared and recorded dividends of \$5.0 million to Westar Energy in 2017.
